Bridgeton Board of Education has caused notice of this meeting to be published by having the date, time and place thereof posted on the bulletin board in the lobby of the Bank Street Administration Building and mailed to the City Clerk of Bridgeton, The Evening News, Bridgeton, Radio Station WSNJ, Bridgeton on January 18, 2011.

#### PUBLIC PARTICIPATION

Mr. Stultz Taylor addressed the Board regarding the termination of the shared services agreement. Mr. Taylor stated that the agreement has been wonderful for the students, Food service has doubled and business services are excellent. Mr. Taylor indicated that they would like to continue the relationship. He stated that the reason given by Dr. Gilson's letter was that there was no limit on the number of students Downe allows to go to the choice district. According to Mr. Taylor, this year would have been the only year that they exceeded the number. Further, he stated that no articulation has occurred between Bridgeton and Downe Township. Finally, he believes that the regulations state that you can not limit the number from their final grade level, so, this would be a mute point. Mr. Taylor would like to see Bridgeton go back to doing more promotion in the school. If the Board will consider rescinding the previous motion to terminate services, they have offered to allow Bridgeton to promote the schools in their news letter. Mr. Taylor asked them to reconsider and that Downe will be adversely affected.
