Happy New Year Bridgeton Team!

On Friday, we notified our community that we will remain 100% remote at least through **February 16, 2021**. This decision was made based on the high rates of COVID-19 transmission throughout the Cumberland County community. When we brought back students for in-person instruction on October 13th, Cumberland County was averaging ten COVID-19 cases a day. Today, we are averaging 100 cases a day. As of Friday, January 8th, Cumberland County had reached "severe outbreak status." While we want all students to return to inperson classes as quickly as possible, our first priority is the safety of our students and staff.



Our District-wide Cameras on Campaign

During last week's two COVID-19 Town Halls, we heard feedback from staff and parents regarding cameras. We heard from teachers who have yet to see the faces of students all year on one end of the spectrum, and we also have teachers who are able to get all or most students to show their faces "at key moments" throughout the lesson.

Because of valid concerns around bandwidth and access to cameras, we will continue to "strongly recommend" cameras are turned on. Staff are encouraged to incentivize showing faces as we know that students who show their faces are more successful than those who do not.

If students/parents are concerned about class-mates seeing things in the background, instead of turning off video for the entire lesson, students should utilize the virtual background feature.
