

I hope each of you had a relaxing and safe Super Bowl weekend. I appreciate all the feedback we received last week regarding our return to inperson learning date. Staff, parent, and restart committee feedback were critical in making an informed decision to have students remain 100% remote through March 12th. While our school community is split in terms of how we should proceed, our decision prioritized safety.

One of the messages we heard loud and clear last week from several pandemic response liaisons was around the number of students per classroom being particularly low back in October, and the need for at least 6-9 students per classroom, once we return, in order to make the experience worth while.


CAMERAS ON CAMPAIGN

STAFF ACCOMMODATIONS UPDATE

All staff should expect to return to in-person reporting on March 11th in preparation for students returning at 50% (double the students reporting in mid-October) on **Monday, March 15th**. If you had 3 students reporting in October; it is likely you will have approximately 6 reporting. Staff should expect half the class minus any students and families opting to remain remote. All district-approved childcare, medical, and/or personal accommodations will expire on March 10th; if you have additional questions regarding the expiration of accommodations, please reach out to Human Resources.

FACILITIES UPDATE

In classrooms across the district, staff will find a new addition to help in cleaning the air. We have purchased the AtmosAir Everest Air Purifiers and have installed them in all classrooms. These units are a 3 stage charcoal and HEPA filter that remove dust and bacteria that can carry virus' in the air. This unit also employs a new technology called Needlepoint Bi-Polar purification which kills virus' and bacteria that pass through the unit. This is enhanced with Ultraviolet light within the unit.
