**Phase 1** – Central office staff and building-based 12-month staff reported safely this summer. (Completed)

Phase 2 – All building-based 10-month and 10.5 month staff will join central office staff in reporting safely to their buildings, offices, and classrooms. (Completed)

Phase 3 – Starting September 21<sup>st</sup>, staff members with childcare needs and staff at a higher risk for contracting COVID-19 are allowed to teach from home, while maintaining sustained student engagement and support.

Phase 4 – 25% of students return for face-to-face instruction--hybrid model on October 13th; staff at a higher risk for contracting COVID-19 and staff with childcare needs are allowed to continue to teach from home.

**Phase 5** - 50% of students return for the hybrid model (date to be determined based on safety)
