## Transitioning from 100\% Remote to Hybrid

Students requesting to remain remote - 1047/5904 = 17\%
Teaching staff requesting an accommodation (medical, child care, and personal) - 113/517 = 21\%

|  | Scenario 1 <br> Staff accommodations maintained Requires coverage flexibility 9 student maximum |
| :---: | :---: |
| School Day for Staff | 5 hours and 55 minutes <br> Remote and in-person staff can end their day after their 40-min prep period (40 minutes after student dismissal). <br> Twice monthly, prep time will be used for a staff meeting. |
| Scheduling | Staff and students keep their current schedules <br> Pre-K will need to make some shifts. |
| Reassignments | No staff reassignments necessary |
| Impact | Five to six students will come in with their devices and complete their virtual lessons from the classroom one day a week. In order to safely accommodate staff requesting childcare, medical, and/or personal accommodations, principals will need the support of in-person colleagues to supervise, not to exceed 9 students daily. In-person students will be able to work with teachers when online students are working independently, as part of the gradual release model. |
